- 8:45-9:15 am** State DCR Update: Urban & Community Forestry
Julie Coop, Massachusetts DCR Urban & Community Forestry Coordinator, will speak about Urban Challenge Grants, the application process, examples of projects available for funding and more.
- 9:15-10:15 am** Utilizing Urban Wood Waste
Sean Mahoney, Program Director, Massachusetts DCR Utilization & Marketing Forestry. The urban forest of metropolitan Boston generates an estimated 643,000 tons of urban wood waste annually. Beyond Boston we have all seen urban tree waste piled up waiting to go to the grinder, but are there ways we can put this resource to better use? Learn what some communities are already doing to recycle waste wood into products with meaningful public benefit, and simple steps municipalities can take to improve their waste management options.

- 10:50-11:40 am** Insect Pests Of 2019: The Old, The New, and the Odd. **Tawny Simisky**, UMass Amherst Extension Entomologist, will present the year's most common insect pests, as seen in the UMass Plant Diagnostic Lab and reported by professionals and the public. Did you notice tattered oak leaves back in June? What about soft scales? Weird acorns? Hear about these strange things as well as bagworms and other pests that were active this season, and get a status update on the invasive spotted lanternfly (*Lycorma delicatula*) in the USA.

- 3:00-4:15 pm** Debris Management in Disasters: Assistance Through Mutual Aid and Coordination. **Michael Russas, MEP**, Section Chief, Massachusetts Emergency Management Agency Response and Field Services. Debris management operations during a disaster often dictate the success and timeliness of a community's ability to respond and recover. This presentation will give an overview of the Massachusetts Emergency Management Agency (MEMA), how MEMA coordinates debris management operations in support of communities, and insights on local public works mutual aid. Using a case study of the 2019 tornadoes on Cape Cod, the speaker will provide some examples of best practices and challenges seen during this event.

1) Municipal OSHA Compliance with the Right to Know and More. **Jennifer Tetreault**, HazCompliance, LLC SafetyNet Compliance Solutions Director, will present the components of OSHA's Right to Know Standard and how it pertains to the Tree Wardens' and Foresters' sector. In addition, other applicable requirements of OSHA will be explored, including a discussion of feasible implementation of the standards.
2) Right-of-Way Herbicide Applications and Developing a Vegetation Management Plan. **Clayton Edwards**, Pesticide Division ROW Coordinator, Massachusetts Department of Agricultural Resources, will present best practices for right-of-way management and will discuss how to draft and submit a municipal Vegetation Management Plan. Specific topics will include winter injury, anthracnose of maple and sycamore, secondary pathogens of oak, white pine dieback, and research updates from the diagnostic lab.
